Consisting of fun and creative problems, competitions have written and oral rounds, as well as individual and team components. Though challenging and non-routine, the problems focus on the 6th through 8th grade standards of The National Council of Teachers of Mathematics. MATHCOUNTS provides the materials for teachers and students to use as they prepare for the competition series. Participants then advance through school, chapter, and state competitions until the top four students are selected from each state to advance to the national competition.

The National Math Club: The National Math Club is an inclusive math enrichment program that provides club leaders with the free resources and materials needed to run a math club. With registration open to schools, organizations and other groups, The National Math Club brings fun and exciting math to students across the country. Formerly known as the MATHCOUNTS Club Program, the National Math Club helps build confidence in students of all ability and interest levels by giving them the opportunity to engage in unique math activities in a relaxed, social setting.
